Fix Your Feline Fund

The Fix Your Feline Fund was established in 2012 for the purpose of assisting low income individuals and families in Dunkirk and Fredonia with the cost of spaying and neutering their cats. Assistance is available to those eligible for one cat per individual/family per year. Fifty dollars (\$50) is available for neutering and \$75 is available for spaying. Funds are limited.



How does the fund work?

- 1. Complete the pertinent information on the opposite side and submit it to:
 - Fix Your Feline Fund/NCCF 212 Lake Shore Drive West
 - 212 Lake Shore Drive wes
 - Dunkirk, New York 14048
- Your application will be reviewed by the Fix Your Feline Fund Committee (Please note that you must meet the criteria of residing in Dunkirk or Fredonia and of being low income.)
- 3. If approved, an authorization voucher will be sent to you. You are not eligible for assistance from this fund if your pet has already been spayed or neutered.
- 4. Take the authorization voucher with you to your pet's spaying/neutering appointment.
- 5. Ask your veterinarian to sign the voucher and return it to the Northern Chautauqua Community Foundation.
- 6. Funds will be paid directly to the veterinarian/clinic You are responsible for the remaining amount of the veterinarian bill.
- 7. Funds are limited and will be distributed on a first come first served basis.
